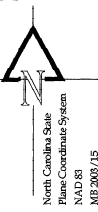

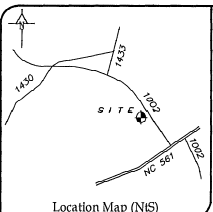
I, Stephen M. Puckett, certify to one or more of the following:

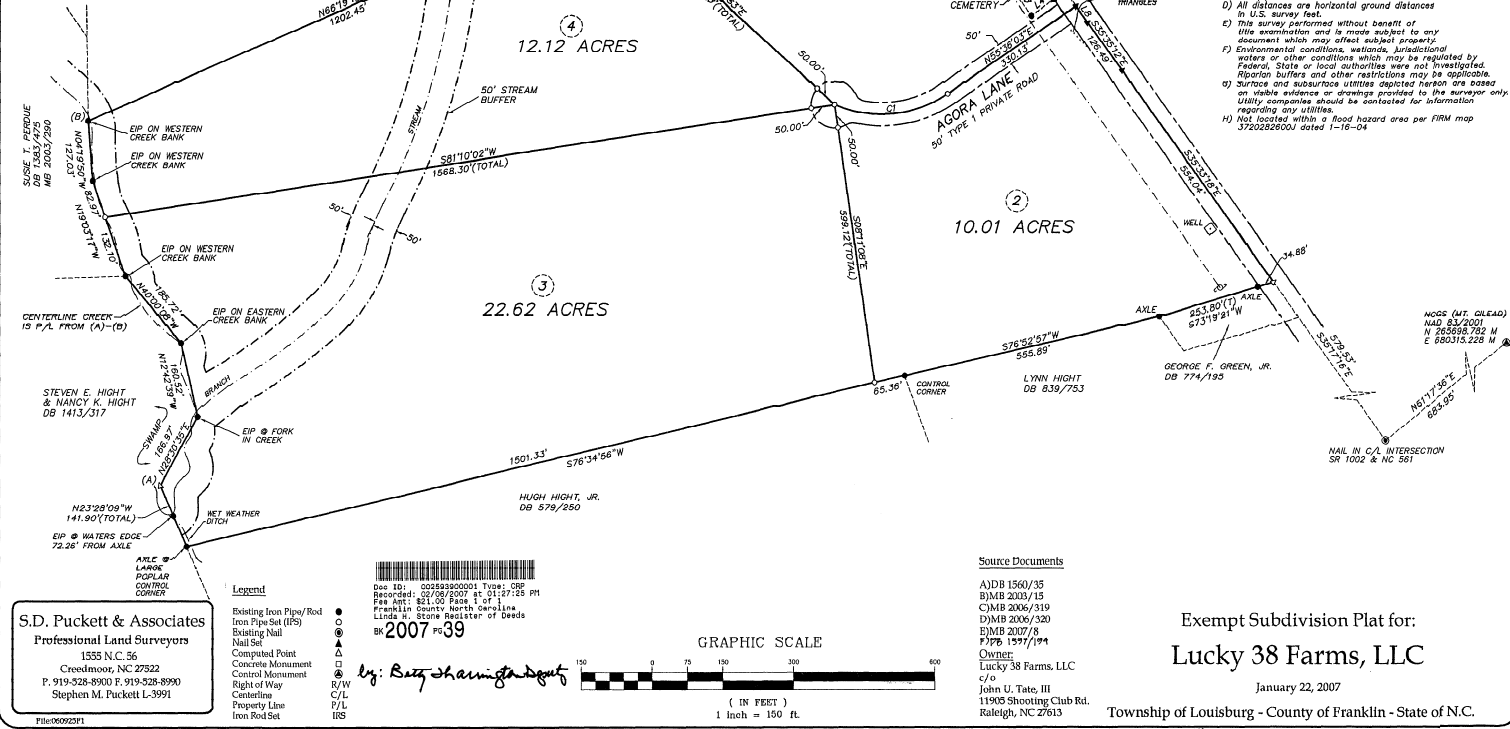

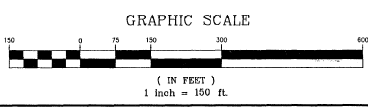
